Domestic Summer Program:  
The domestic summer program provided week-long voluntary community service opportunities for 1,900 young people and their adult leaders. These service-learning experiences took place in six different communities throughout the Western United States. Volunteers completed 119 significant home repair projects, including wheelchair ramps, new roofs, and other types of repairs which improve the safety and liveability of homes. The domestic summer program employed forty-two staff persons for the summer.

Weekends of Service and Alternative Breaks:  
SSP's Weekend of Service and Alternative Break sessions took place in three different project locations in the Fall, Winter and Spring. Sessions took place in South Los Angeles, CA; Sacramento, CA; Portland, OR; and Vernonia, OR. Two hundred thirty-six volunteers participated in the Weekend Sessions. Nine different groups participated in one of the Alternative Break sessions.

SSP Nicaragua:  
This year, SSP launched a immersion service program in Nicaragua in partnership with another nonprofit organization called Seeds of Learning (SOL). SOL has more than twenty years of experience working in several rural Nicaraguan communities, where they focus on improving educational opportunities. Volunteer groups help to build and rehabilitate local schools, and the volunteer fees fund scholarships, year-round staffing and scholarship programs.

Part III, 3: Our SSP Nicaragua program was launched this year in partnership with Seeds of Learning, a nonprofit organization with over twenty years of experience building schools and supporting educational opportunities in several rural Nicaraguan communities. A group of thirteen participants spent ten days in Nicaragua in this successful pilot effort. Our Guatemala Program has been canceled.
